HOW TO PARTICIPATE

M-1 invites the fighters from each continent to register for participation in the Selection fights.

Out of the fighters that are registered to participate in the Selections, a qualified jury will make the final decision which eight (8) fighters in each weight category will actually enter the first round of Selection.

If you want to join M-1 there are several things which you have to keep in mind. If you are invited to fight in the M-1 Selection you will be allowed to bring one person with you. M-1 will pay hotel and travel and a per diem of 50 USD per person.

If you decide to join M-1 you will have to sign a contract with M-1 which a.o. contains the following points.

For the first fight in the Selection a fighter will be paid 500 USD with a win bonus of 250 USD, if the fighter wins and moves up to the semi-finals of the selection he will be paid 750 USD with a 250 USD win bonus, if a fighter wins and moves up to the finals he will be paid 1000 USD + 250 USD win bonus and the overall winners will receive a spot in the M-1 Challenge.

In the M-1 Challenge fighters are paid 1500 USD plus a win bonus of 250 USD, if the fighter wins they will be paid 1750 USD plus a win bonus of 250 USD and if a fighter wins again he will be paid 2000 USD plus a 250 USD win bonus.

M-1 may deduct from your Purse and Win Bonus all permissible or required deductions and tax withholding (whether domestic or foreign), and may offset against any sums advanced to you by promoter or otherwise due from you to promoter.

The promotional and ancillary rights granted by you

shall be the sole property of M-1 in perpetuity worldwide, which M-1 shall hold free and clear from any and all claims of you or anyone claiming through you. The promotional and ancillary rights are referred to collectively, where appropriate, as the "Rights" and shall include, without limitation, the following, which are all in perpetuity throughout the world.

The contract will be for two years with a minimum of 3 fights a year but M-1 holds the right to terminate the contract at any time when a fighter loses.

Upon the expiration of the contract you will sign you agree to negotiate exclusively with M-1 for sixty (60) days regarding the extension or renewal of the Term. If you and M-1 fail to reach agreement upon the terms and conditions of an extension of the contract within the 60 day negotiation period, you will be free to negotiate with any other organization. However, M-1 will have the right to match the terms of any promotional agreement offered to you by another organization for a period of one (1) year following the expiration of the contract. You cannot enter into a contract or agreement with another organization within one (1) year of the expiration of the contract without submitting written notice of the offer terms and conditions and providing M-1 the right to match.
